### **Budget Hearing**

It was moved by Mrs. Lachowicz and seconded by Mrs. Lahart that the Board adjourn into a public hearing for the 2014-2015 Budget. Motion carried by unanimous consent. The Budget was delivered to Board members prior to the meeting. Mrs. Yerkes entertained comments, questions, or objections to the proposed FY 15 School District 128 budget. The tentative FY 15 budget has been on public display for 30 days as required by law. There were no questions or objections to the proposed School District 128 FY 15 budget as presented.
